The stallion fee is **\$1000** This includes the **\$250.00** non-refundable booking fee (Deposit of breeding) which is payable upon execution of this contract and includes the first chute and (FedEx)shipment. *Included In the \$1000 All Inclusive Fee (Deposit of Breeding \$250/ Breeding Fee: \$450 / Chute/Shipping: \$300)*

Additional Costs For Fresh are as follows:

Counter to Counter: \$400 FedEx: \$200 Farm Pick Up: \$100

Additional Collections for Same Year is \$0

The following year (rebreed) it will be \$100 plus your "shipping"

Cooled Shipped Semen: **1.** Mares on the premises of Burnin' B Ranch have a breeding priority on any given day, therefore , we make no guarantee cooled semen will be available for a specific day. Burnin' B Ranch is not responsible for untimely deliveries and/or condition of shipped semen, as we have no control of shipment after it leaves our custody. **2.** The mare owner understands that they must comply with the following when dealing with shipped semen; \* Confirm orders for semen at least 24 hrs prior to the day of shipment. \* \*Collection days will be M-W-F\* **3.** Cancellations must be made by 8:00 am CST the day of shipment. Cancellations after that will be subject to a \$100.00 cancellation fee. **4.** Burnin' B Ranch, agrees to ship cooled semen as described above. If the mare fails to settle for any reason the mare owner will not hold Burnin' B Ranch, responsible or liable for damages to the semen. Burnin' B Ranch, reserves the right to require the mare to be brought to a nearby breeding facility to be bred in such a case. **4a.** Mare care will be handled by the nearby breeding facility or vet. Mare owner understands and complies with the following: **5.** A breeder's certificate will be issued after all expenses have been paid and Mare Owner notifies the breeder of a live foal. **6.** Under Oklahoma Law (The Oklahoma Equine Activities Liability Act Section 50.1 of Title 76) An equine professional is not liable for injury or death of a participant in equine activities resulting from inherent risks of equine activities. This contract will be governed by the laws of the State of Oklahoma. It is understood that Burnin' B Ranch, its

owners, employees and guests shall not be liable for any injury, escape, liability or death of any horse on the breeding premises **7. A copy of the mare's registration papers (both sides)** **8. Live Foal Guarantee**  
\*Live foal means the foal shall stand and nurse. It is understood that if the mare proves barren, aborts her foal, or if foal is born stillborn, a return breeding will be guaranteed the following year only at Burnin' B Ranch, providing that proper notification is received. A live foal guarantee will apply to those mares that are certified in foal by a licensed veterinarian. Confirmation must be sent to Burnin' B Ranch, in order to guarantee a rebreed. Confirmation can be in form of letter from attending licensed veterinarian. **9. Rebreeds**—if the mare does not produce a live foal the first breeding season, the mare owner is entitled to a rebreed the following year. Mare owner will be subject to an additional chute fee, plus any additional attending veterinarian fees. **10.** The Mare Owner agrees that the mare presented for breeding will be in good health and in sound breeding condition. Any mare certified by the attending veterinarian to not be in sound breeding condition shall not be bred. **11.** When the Mare Owner signs this contract and returns it to the Breeder it shall then become a valid and binding contract upon both parties. This contract is not valid unless completed in full. All unpaid expenses will be paid upon receipt of an invoice or when the mare is picked up.
